## **Section 4 - First Aid Measures**

#### Inhalation

If inhaled, remove affected person from contaminated area. Remove contaminated clothing and loosen remaining clothing. Allow patient to assume most comfortable position. Apply artificial respiration if not breathing. Seek medical attention.

## Ingestion

Do not induce vomiting. Wash out mouth thoroughly with water. If vomiting occurs, give further water to achieve effective dilution. Seek immediate medical attention.

#### Skin

Wash skin with plenty of water. Ensure contaminated clothing is washed before re-use or discard. Seek medical attention if burning, irritation or redness develops.

#### Eye

If in eyes, hold eyelids apart and flush the eyes continuously with running water. Remove contact lenses. Continue flushing until advised to stop by the Poisons Information Centre or a doctor, or for at least 15 minutes. Seek immediate medical attention.

#### Section 6 - Accidental Release Measures

## Spills & Disposal

Minor spills do not normally need any special clean up measures. In the event of a large spill, prevent spillage from entering watercourses. Wear appropriate protective equipment (as listed in Section 8 of this SDS) to prevent eye and skin contamination. Spilt material may result in a slip hazard and should be absorbed into dry, inert material to be collected in appropriately labelled

containers for disposal by an approved agaent according to local regulations.

Residual deposits will remain slippery, wash down with excess water. If contamination of drains or sewers occurs advise local emergency services.

#### Clean-up Methods - Large Spillages

For large spills or tank rupture, consider initial evacuation to a distance of 200m in all directions. Stop leak if safe to do so. If available use water spray to disperse vapours. Wear appropriate PPE as listed in Section 8 of this SDS to prevent skin and eye contamination.

## **Section 7 - Handling and Storage**

## **Precautions for Safe Handling**

Avoid contact with incompatible materials. When handling DO NOT eat, drink or smoke. Keep containers closed at all times. Avoid physical damage to containers. Always wash hands with water after handling.

## Conditions for safe storage, including any incompatibilities

Store in a cool dry well-ventilated area. Do not store in aluminium or light alloy containers. Keep containers closed when not in use, securely sealed and protected against physical damage. Inspect regularly for deficiencies such as damage or leaks.

# **Section 8 - Exposure Controls and Personal Protection**

## **Engineering Controls**

This substance is hazardous and should be used with a local exhaust ventilation system, drawing mists and fumes away from workers' breathing zone. If the engineering controls are not sufficient to maintain concentrations of dust below the exposure standards, suitable respiratory protection must be worn.

# **Respiratory Protection**

Not required for normal cleaning operations. Where high contaminant pray mist or vapour levels exist, the following additional equipment is required: For short, elevated exposures eg. spillages - Appropriate organic vapour cartridge respirator as per the requirements of AS/NZ 1715 & AS/NZ 1716.

For prolonged exposure and confined spaces - full face, air supplied or self contained breathing apparatus.

#### **Eye and Face Protection**

Generally not required to handle properly diluted solutions of the product. The use of safety glasses with side shield protection, goggles or face shield is recommended to handle in quantity, cleaning up spills, decanting etc.

#### **Hand Protection**

Generally not required to handle properly diluted solutions of the product. Overalls, work boots & elbow length gloves are recommended for handling the concentrated product in quantity, cleaning up spills, decanting etc.

## **Chemical Stability**

Stable under normal conditions of storage and handling.

May corrode mild steel, copper, aluminium & zinc fittings. May accelerate environmental stress cracking of some polymers. Natural rubber is unaffected but some synthetic rubbers may develop surface stickiness. Incompatible with anionic surfactants, certain organic silicates & nitric acid.

#### Ingestion

Harmful if swallowed. Ingestion of this product may cause nausea, vomiting, abdominal pain and irritation to the mouth, throat and stomach. May affect behaviour (central nervous system depression) and metabolism. May also effect the respiratory and cardiovascular system, liver and kidneys.

#### Inhalation

Inhalation of mists and aerosols can produce mucous membrane & respiratory irritation. Exposure to high concentrations of the product in liquid form or as a mist may lead to possible harmful effects including bronchitis, pneumonia and pulmonary oedema.

#### Skin

Causes skin burns. Skin contact can cause redness, itching, irritation and chemical burns if extended contact with concentrated product.

#### Eye

## **Uses and Restrictions**

S2 Sanitiser Non Rinse is a sanitiser designed to be used on surfaces which have already been cleaned with a detergent, or for light duty cleaning and sanitising applications. Swab surfaces with a sponge, mop or brush. Allow contact time. Rinse surface with potable water, if desired.

FOOD PROCESSING - After cleaning, dispense 75 ml of product per 10 litres of water. Leave solution on as a non-rinse disinfectant or rinse with potable water.



S2 is particularly suited to manual washing of implements using the two sink method i.e. washing utensils in one sink with a detergent, then place into a second sink containing a solution of S2 Sanitising Non Rinse. Rinse and allow to air dry.

NON RINSE SANITISING - Using as a Spray and Wipe, make a solution of 10ml of product in 1L of water, wipe area with product and leave on as a non-rinse sanitiser.

MOULD - To prevent mould from returning as quickly, remove all trace of mould using a chlorinated product such as "Domestos", rinse thoroughly, then apply a solution of 50ml of product per 10 litres of water.

#### **User Information**

S2 Sanitiser Non Rinse is designed for use in food preparation areas where a high standard of hygiene is required. May be used on all surfaces where food is prepared or stored, and where a perfume free product is desirable. S2 Sanitiser Non Rinse can be used to soak cutting boards, knives, tongs, utensils etc. S2 is also used to sanitise cold rooms, store rooms, larders, chopping blocks etc.
