4. FIRST-AID MEASURES

Inhalation

If inhaled, remove affected person from contaminated area and keep at rest in a position comfortable for breathing. Keep at rest until recovered. If symptoms develop and/or persist seek medical attention.

Skin

If on skin (or hair) remove/take off all contaminated clothing immediately. Wash/rinse skin gently and thoroughly with water/shower and non-abrasive soap for 15 minutes after handling. Contaminated work clothing should not be allowed out of the workplace. Ensure contaminated clothing is washed before re-use or discard. Seek immediate medical attention. If skin irritation or rash occurs please advise medical physician.

Eye contact

If in eyes, hold eyelids apart and flush the eyes continuously with running water. Remove contact lenses, if present and easy to do. Continue flushing for several minutes until all contaminants are washed out completely. If symptoms develop and/or persist seek medical attention.

5. FIRE-FIGHTING MEASURES

Suitable Extinguishing Media

6. ACCIDENTAL RELEASE MEASURES

Emergency Procedures

Wear appropriate personal protective equipment and clothing to prevent exposure. Increase ventilation. If possible contain the spill. Place inert absorbent material onto spillage. Collect the material and place into a suitable labelled container. Do not dilute material but contain. Dispose of waste according to the applicable local and national regulations. If contamination of sewers or waterways occurs inform the local water and waste management authorities in accordance with local regulations. As a water based product, if spilt on electrical equipment the product will cause short-circuits.

7. HANDLING AND STORAGE

Precautions for Safe Handling

Avoid inhalation of vapours and mists, and skin or eye contact. Use only in a well ventilated area. Keep containers sealed when not in use. Prevent the build up of mists or vapours in the work atmosphere. Maintain high standards of personal hygiene i.e. Washing hands prior to eating, drinking, smoking or using toilet facilities. Protect from freezing.

Conditions for safe storage, including any incompatibilities

Store in a cool, dry, well-ventilated area, out of direct sunlight. Store in suitable, labelled containers. Keep containers tightly closed. Store away from incompatible materials. Ensure that storage conditions comply with applicable local and national regulations.

8. EXPOSURE CONTROLS/PERSONAL PROTECTION

Occupational exposure limit values

No exposure standards have been established for the mixture. However, over-exposure to some chemicals may result in enhancement of pre-existing adverse medical conditions and/or allergic reactions and should be kept to the least possible levels.

Appropriate Engineering Controls

This substance is hazardous and should be used with a local exhaust ventilation system, drawing vapours away from workers' breathing zone.
